The IEE Regulations requires that a 16A connection is the only acceptable means of connecting to a CBC external power supply. 13A connections alone, or by use of a 13A/16A adaptor are not acceptable and will not be connected to the Show's power supply. It is your responsibility to provide a 16A 'male' socket in order to connect to the Show's supply; it is a requirement that the cable used by you shall be less than 2.5mm² duty cable.

- 16A supplies are available, however, these are not to be exceeded in one single feed from the supply
- 1 item of electrical equipment will require one 16A connection and feed. More than 1 item of equipment to be connected must be supplied by a 16A multi-gang. You are solely responsible for all wiring and equipment within your stall up to the Show's side of the 16A supply connection
- All electrical equipment to be used by the trader must display a current and valid Portable Appliance Test Certificate
- No connection will be made to the Show's power supply unless the inspection electrician is satisfied the above requirements have been met

Food Hall Criteria

- Unlimited numbers of the same, or similar products will not be accepted – space will be allocated on a ‘first come – first served’ basis
- All produce sold must be grown, reared, caught processed or made by the stall holder: producers may sell only their own produce/goods
- Local ingredients – processed goods must contain at least 50% ingredients of local origin: the base product should be significantly altered to qualify for sale at the Show
- People attending the stall/stand must be clean and tidy
- Smoking in the Food Hall is strictly prohibited
- Adequate hand washing facilities must be provided where appropriate – as required by the local EHO
- Stalls/stands must be kept tidy and free from hazards
- Stallholders are responsible for removing rubbish to allocated collection areas provided.
- Alcohol sales: you must agree to abide by the Operate a Challenge 25 policy if the purpose of your business is the sale of alcohol. Your stall must be manned by a person over 18 for the sale of alcohol.
- Allergens and food labelling: under legislation you must ensure that by attending The Chickerell Steam and Vintage Show food hall you are aware of your obligations regarding food labelling and allergan declaration.

Health & Safety Requirements

All exhibitors must be on site and set up / running by 0945 hours on show days – there will be no entry to the site after this time.

All non – display vehicles to leave the show site by 0930 hrs on show days

Shut down for exhibits is 1700 hours on Saturday and 1600 hrs on Sunday

There will be no vehicle movement on or off of the site before 1800 hrs Saturday and 1600 hrs on the Sunday

Any problems / complaints / disputes will be dealt with by the Directors and the Health and Safety Officer – their decision is final.

MAXIMUM SHOW SITE SPEED LIMIT IN FORCE OF 5MPH. PLEASE RESPECT THE SPEED ON SITE.
